WHEN WE LAUNCHED PROJECT VOICE, IT WAS THE FIRST DIGITAL HEALTH PROGRAM TO IMPROVE OUTCOMES FOR PATIENTS WITH PERIPHERAL ARTERY DISEASE (PAD). The award supports crucial research that enables them to compete for future research funding. Wylie Scholars become North America's world-class vascular surgeon-scientists; many are now chiefs at major academic centers, prominent leaders in the field, and play a key role in our programs. Since 1996, we've supported 24 surgeon-scientists at 15 institutions around the country who are transforming patient care. The average return on investment for follow-on research funding is 30:1.
